ADVISORY FOR ADMISSION OF CHILDREN IN APSs AND APPSs

1. Article 206 of Rules and Regulations for APSs, Seventh Edition, 25 Mar 2023 lays down age limit for admission of class I to X has been amended vide HQ AWES letter No B/45902/Amdt/APS/AWES dt 08 Feb 2023. The age criteria has been amended to minimum 6 years and maximum 8 years for admission to class-I. This provision has been incorporated to align the admissions in Class-I with the NEP 2020.

2. The BoA has analysed the issue in detail. Keeping in mind the service and tenure profiles of service personnel, a conscious decision has been taken to provide a six months relaxation for Academic Year 2023-24 only for wards of service personnel incl ESM category i.e. children born between 02 Apr 2017 to 30 Sep 2017 be granted admission in Class I in Academic Year 2023-24.

2. Amendment to the age of admission in Class 1 wef AY 2023-24 was issued in accordance with the age criteria for admission as laid down by KVS, which are aligned to NEP 2020. Additionally, the age of admission issued by KVS for Class 1 was upheld by the Hon'ble Supreme Court. This year, the MoE has also instructed all State and UTs to make 6 years as the min age for admission in Class 1.

3. However, a number of representations are being received from parents whose children are already studying in UKG and had taken admission in Nursery prior to issuance of the letter ref at Para 1 (a) above.

4. In order to provide one time dispensation to the said category, the competent auth has decided to grant a six months waiver to children born between 02 Apr to 30 Sep 2017, for admission in **Class 1 for the Academic Year : 2023-24 only**.

5. For such cases, an affidavit duly notarized should be obtained from the parents to absolve AWES/APS from any detrimental consequence arising from admitting on underage child in APS. Sample of affidavit is attached for ready reference.

6. The amendment issued vide letter ref Para 1 (c) above will now be applicable from Academic Year : 2024-25 only.
