Dean Gen Pande Sir,

Kindly refer to my earlier letter no. 4.1/45585/2022-23 dated 11th April, 2023 which was written to extend the benefit of concessional scheme to the Army personnel and their wards in the last Academic session. I am happy to mention that in last 2-3 years a no. of the Army Personnel had taken the advantage of our concessional scheme and admitted their wards in different courses.

Considering the response of Army personnel in the last Academic session (2023-24), the Management has decided to extend 30% concession in tuition fee in all courses Viz: B.Tech, B.Pharm, D.Pharm, M. Pharm, MBA, MCA\*, BCA & BBA for the Academic Session 2024-25. Further, to reduce financial burden on the Army personnel, fee can be deposited in two installments. The Management has also introduced some financial incentives for meritorious students on the basis of their performance.

The Raj Kumar Goel Institute of Technology, Ghaziabad U.P. (College code 033) (RKGIT in short) was established in the year 2000. # Eligibility Criteria for various Courses

#### FOR ADMISSION TO FIRST YEAR B. Tech

B. Tech is a four year degree course. For direct admission to first year of B. Tech a candidate must have passed intermediate examination of U.P. Board or 10 + 2 level examination or its equivalent from any recognized board / University with minimum aggregate marks of 45% for General & OBC and 40% for SC / ST category in the Subject group (Physics, Chemistry & Mathematics) without grace marks.

#### FOR ADMISSION TO FIRST YEAR B.PHARM

B.Pharm is a four year degree course. For direct admission to first year of B.Pharm a candidate must have clearly passed intermediate examination of U.P. Board or 10+2 level examination or its equivalent from any recognized Board / University with Physics, Chemistry, and Mathematics/Biology, securing minimum 50% marks (45% marks for SC/ST Category) in aggregate in required three subjects.

#### FOR ADMISSION TO FIRST YEAR D.PHARM

D.Pharm is a two year diploma course. For direct admission to first year of D.Pharm a candidate must have clearly passed intermediate examination of U.P. Board or 10+2 level examination or its equivalent from any recognized Board / University with Physics, Chemistry, and Mathematics/Biology, securing minimum 50% marks (45% marks for SC/ST Category) in aggregate in required three subjects.

#### \* FOR ADMISSION TO SECOND YEAR (LATERAL ENTRY) OF B. Tech

A candidate who has passed 3 years Diploma in Engineering course securing minimum 45% marks for General & OBC and 40% marks for SC / ST category in aggregate or 3 years B.Sc. degree plus having passed 10+2 exam with Mathematics as one subject, securing minimum aggregate marks 45% for General & OBC and 40% for SC / ST in B.Sc.

#### FOR ADMISSION TO SECOND YEAR (LATERAL ENTRY) OF B. PHARM

A Candidate who has passed 2 years Diploma in Pharmacy approved by the Pharmacy Council of India (PCI) recognized by the Board of Technical Education, U.P. is eligible for admission to second year of B. Pharm.

#### FOR ADMISSION TO FIRST YEAR M.PHARM (Post Graduate Course)

M.Pharm is a two year PG course. For admission to first year of M.Pharm a candidate should have B.Pharm degree from a PCI approved institute and should have scored atleast 65% marks in B.Pharm.

#### \* FOR ADMISSION TO FIRST YEAR MBA (Post Graduate Course)

MBA is a two year PG course. For direct admission to first year of MBA a candidate must have passed bachelors degree of minimum three years duration from any recognized University of India. Passing clearly without grace marks with an aggregate of minimum 50% marks for General & OBC and 45% marks for SC / ST Category. Also the candidates who are waiting for their final year graduation result can also apply for MBA programme but their candidature will be subject to clearing the qualifying examination as per the above mentioned eligibility criteria.

#### FOR ADMISSION TO FIRST YEAR MCA (Post Graduate Course)

MCA is a two year PG course. For direct admission to first year of MCA a candidate must have passed backclors degree from any recognized University, (e.g.: B.E. / B.Tech./ B.Sc / B.Com. / B.A./ B. Voc./ BCA etc.,) preferably with Mathematics at 10+2 level or at Graduation level and obtained atleast 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination.

#### FOR ADMISSION TO FIRST YEAR BBA

BBA is a three year course. For direct admission to first year of BBA a candidate should have passed 10+2 (all streams) or its equivalent examination with 45% marks for General and OBC and 40% marks for SC/ST from a recognized Board/ University. Also, the students who appeared in 10+2 examinations and are awaiting their result, are also eligible to apply but their candidature will be subject to clearing the qualifying examination.

#### FOR ADMISSION TO FIRST YEAR BCA

BCA is a three year course. For direct admission to first year of BCA a candidate should have passed 10+2 (Art with maths)/Ag/Pio/Science/Commerce), Maths mandatory at High School or Intermediate with 45% marks for General and OBC and 40% marks for SC/ST from a recognized Board/ University. Also, the students who appeared in 10+2 examinations and are awaiting their result, are also eligible to apply but their candidature will be subject to clearing the qualifying examination.
